



## **Ross Moore Law, Car Accident Attorney, Responds to 2022 Marietta Traffic Data Showing 4,535 Collisions**

"Each of these 4,535 collisions represents families facing immediate medical expenses and long-term financial challenges," stated Ross Moore, founding attorney at the firm. "The data shows a clear pattern of preventable accidents caused by distracted driving, excessive speed, and failure to yield right of way, which continue to impact our community."

Georgia's fault-based insurance system requires accident victims to establish liability through comprehensive documentation, including accident scene evidence, witness statements, and medical records. This process becomes particularly complex when dealing with suspected serious injuries, which often require expert medical testimony to demonstrate the full extent of damages and future care needs.

The firm has implemented new case management protocols to address common challenges faced by collision victims. These include immediate evidence preservation procedures, structured communication with insurance carriers, and systematic documentation of medical treatment and expenses. Data analysis reveals that rear-end collisions, intersection crashes, and multi-vehicle accidents comprise the majority of Marietta's traffic incidents. Each collision type presents distinct legal considerations regarding fault determination and damage assessment under Georgia traffic law.

The suspected serious injury designation affects both immediate medical treatment authorization and long-term compensation calculations. Insurance companies typically contest these classifications, requiring detailed medical documentation to support claims for ongoing rehabilitation, lost earning capacity, and future medical expenses.
