In a field where surgical credentials can vary widely, Dr. Michael A. Dr. Brusco's credentials were earned through a rigorous process involving verification of thousands of documented cases, comprehensive oral examinations, and peer-reviewed assessment by an international panel of refractive experts. His Fellowship also requires continuous professional education to ensure adherence to evolving global standards in surgical safety and innovation. With more than 51,000 vision correction procedures performed, including over 45,000 corneal-based surgeries and 6,000 lens-based procedures, Dr. Brusco has built one of the nation's most extensive surgical records in refractive care. At one point, he performed nearly one percent of all LASIK procedures in the United States annually. His technical skill and consistent outcomes have made him a trusted authority in advanced laser and lens-based vision correction techniques. He is also an Assistant Professor of Ophthalmology at George Washington University, where he contributes to the training of future ophthalmologists and promotes evidence-based surgical standards.

The WCRS certification's value lies in its objectivity. Traditional ophthalmology board certification validates a physician's overall medical knowledge but does not measure refractive surgery outcomes or procedural experience. In contrast, the WCRS Fellowship process examines case complexity, complication management, and long-term surgical results. Dr. Brusco's Fellowship verifies mastery across the full spectrum of vision correction procedures, ensuring that patients benefit from treatment guided by data, precision, and professional accountability.

The article further notes that the Fellowship's focus on education and peer review aligns with global efforts to standardize surgical excellence in refractive medicine. Each WCRS Fellow must demonstrate proficiency across multiple systems and technologies, including femtosecond laser-assisted LASIK, surface ablation procedures, and phakic intraocular lens implantation. The certification underscores patient safety through adherence to evidence-based practices and strict ethical oversight.

Beyond his Fellowship, Dr. Brusco is recognized internationally as a contributor to refractive surgery standards and surgical training. As a founding member of the WCRS, he helped shape many of the evaluation benchmarks now used to assess surgeon performance worldwide. He has been named a STAAR Top 100 International Surgeon multiple times, reflecting his contribution to the advancement of vision correction technology and outcomes. His membership in the American Academy of Ophthalmology, the American Society of Cataract and Refractive Surgery, and the Refractive Surgery Alliance further demonstrates his involvement in maintaining and improving professional standards within the specialty.

Dr. Brusco's experience extends beyond civilian practice. His earlier work performing vision correction procedures for U.S. military personnel—including pilots and special operations units—through the Warfighter Refractive Eye Surgery Program at Fort Riley reflects a high level of precision and trust placed in his surgical expertise. This background has informed his approach to complex civilian cases, reinforcing the importance of safety, readiness, and individualized treatment planning.

Patients throughout Northern Virginia, Washington D.C., and the broader DMV region now have convenient access to a WCRS-certified refractive surgeon without the need to travel long distances for care. Brusco Vision, located in Falls Church, offers an advanced clinical setting equipped with Alcon and ZEISS laser systems, designed to optimize outcomes through detailed diagnostic and surgical precision.

The recognition of Dr. Brusco's Fellowship also invites broader discussion within the ophthalmology community regarding the need for standardized global benchmarks in refractive surgery training. As laser vision correction becomes more widespread, the distinction between general ophthalmology certification and refractive subspecialty expertise is becoming increasingly relevant to patients, educators, and researchers alike.
