

Hannah Law Announces Critical Estate Tax Exemption Increase to \$13.99 Million for 2025

The current exemption levels, which allow married couples to shield nearly \$28 million from federal estate taxes, face significant reduction at the end of 2025. Without congressional action, these thresholds will automatically revert to approximately \$5 million per individual, adjusted for inflation, when current tax provisions expire.
