The settlement, reached in 2025, addresses damages from an accident in which a commercial trucking company's vehicle t-boned the client's vehicle in Kennesaw, resulting in multiple bone fractures, a concussion, and the need for continued medical care. The case demonstrates the firm's capacity to handle complex commercial vehicle accident claims in Cobb County and throughout the greater Atlanta region.
