According to ATTOM Data Solutions, Florida foreclosure activity in October 2025 reached one in every 1,829 housing units with 5,512 foreclosure filings, while the state ranked second nationally with 15,198 foreclosure starts in the first half of 2025.

"Florida homeowners face diverse circumstances requiring flexible selling solutions," said Ellie Verdura, Founder and CEO of Cornerstone Homebuyers. "Our expanded service may be an option for sellers who do not want to wait months for traditional market transactions or invest in costly home repairs."

According to Florida REALTORS February 2025 report, cash transactions vary significantly across major metropolitan markets. West Palm Beach leads nationally at 49 percent, followed by Jacksonville at 46.2 percent, Tampa Bay at 42.8 percent, Fort Lauderdale at approximately 40 percent, and Miami at 38 percent. Recent data from the MIAMI Association of REALTORS shows Miami all-cash sales increased 17.3 percent year-over-year in October 2025, while Miami ranked No. 2 as a top housing market in the U.S. for 2025.

As cash home buyers operating across all Florida markets, Cornerstone Homebuyers serves major metropolitan areas and surrounding communities. The company closes cash transactions typically in 7 to 21 days compared to typical 30 to 45 days for financed purchases, according to Zillow's 2025 market analysis. This accelerated timeline benefits sellers managing foreclosure proceedings, inherited properties, divorce settlements, employment relocations, or properties requiring substantial repairs.
