According to epidemiological data from the U.S. Department of Health and Human Services, approximately one in four American adults?roughly 54 million people?have diagnosed arthritis, representing a leading cause of disability and chronic pain in the United States. The condition requires consistent, ongoing treatment to manage symptoms effectively. Yet clinic-based physical therapy access remains limited by geographic proximity, transportation availability, and associated costs, creating gaps in care that directly impact patient outcomes.?

Research published in clinical rehabilitation literature documents that supervised exercise therapy and physical treatment protocols produce statistically significant improvements in pain management, with benefits extending across various arthritis types, including osteoarthritis and rheumatoid arthritis. Physical therapy interventions address multiple mechanisms contributing to arthritis symptoms: reducing joint inflammation, increasing flexibility and strength through targeted exercise, and teaching proper body mechanics for daily activities.?

A randomized controlled trial comparing in-person physical therapy with internet-based exercise training programs for knee osteoarthritis found that internet-based intervention produced comparable outcomes to traditional clinic-based treatment, with participants reporting enhanced consistency in completing prescribed exercises.
