



## **Ross Moore Law Reveals Marietta Commuter Accidents 42 Percent Higher During Weekdays**

The afternoon period proves particularly hazardous as drivers navigate home after work. Factors contributing to increased accident risk during these hours include driver fatigue from the workday, rushing to reach destinations, and the dangerous tendency for regular commuters to operate on autopilot along familiar routes. This automatic driving mode can cause motorists to miss critical hazards that require immediate attention.

"Many of our clients are injured during their regular commute to or from work, and these accidents often result in significant disruptions to their employment and income," said Ross Moore, founder of the firm. "Drivers on familiar routes frequently experience a false sense of security that leads to decreased vigilance, especially during the afternoon hours when fatigue compounds the risk."

The psychological aspect of commute driving presents unique challenges. When drivers travel the same route daily, their attention can drift, leading to delayed reaction times when unexpected situations arise. Distracted driving behaviors, such as checking work emails at traffic lights or making phone calls while in slow-moving traffic, further elevate accident risks during commute hours.

For workers injured during their commute, legal considerations become complex. These accidents typically fall outside workers' compensation coverage, as traveling to and from work is generally not considered within the scope of employment. This distinction makes personal injury claims crucial for recovering damages, including medical expenses and lost wages resulting from injuries that prevent victims from working.
