The firm notes that drivers have only seven days from arrest to request a Department of Motor Vehicles hearing to contest license suspension, making immediate legal consultation critical.

The firm's defense strategies address both traditional alcohol-related charges and the increasing number of marijuana DUI cases in Colorado. Since recreational cannabis legalization, the state has seen a steady rise in drug-impaired driving arrests, particularly among out-of-state visitors unfamiliar with Colorado's strict enforcement standards.

DUI Attorneys at DUI Law Firm Denver report that many clients are unaware of the full consequences of a DUI conviction, which extend beyond criminal penalties. Common defense strategies include challenging the legality of the initial traffic stop, questioning the accuracy of chemical testing equipment, and identifying procedural violations that may lead to case dismissal.
