Falls, slips, and trips accounted for 43 of those construction deaths, representing the leading cause of fatal workplace injuries statewide. Florida construction workers experienced 3,490 nonfatal occupational injuries and illnesses requiring medical treatment beyond first aid in 2019, with recent years showing similar patterns.

Healthcare, manufacturing, and transportation industries in the Tampa Bay area also generate substantial numbers of workplace injury cases requiring legal representation.

Florida operates under a no-fault workers compensation system requiring most employers to carry coverage for workplace injuries. Workers injured on the job must report incidents to supervisors within 30 days and navigate complex insurance procedures to secure medical treatment and wage replacement benefits. Many injured workers face claim denials or benefit limitations from insurance carriers, creating the need for experienced legal counsel to protect their rights under Florida workers compensation law.
