



## **TurnKey Sod Establishes Project Assessment Policy for Sod Services**

TurnKey Sod established a project assessment policy for all sod services in early 2025. The policy applies to sod installation, sod replacement, and sod delivery categories, enabling property owners to receive project evaluations and cost information prior to service commitments.

TurnKey Sod operates as a sod contractor, handling residential and commercial properties. The company maintains licensing and insurance coverage for sod operations. Service categories include sod installation, which involves placing new sod on prepared ground surfaces. Sod replacement addresses removal and replacement of existing turf. Sod delivery transports sod materials to project sites.

The company works with four grass varieties suited to the regional climate and soil conditions. Bermuda grass represents one variety within the TurnKey Sod product selection. St. Augustine grass constitutes another available variety, with characteristics suited to the regional environment. Centipede grass is included in the grass type options. Zoysia grass completes the four-variety selection available through the company.

Each grass variety carries distinct characteristics affecting maintenance requirements, appearance, and

growing conditions. TurnKey Sod personnel assess soil type, sunlight exposure, and property-specific requirements to identify appropriate grass variety matches for individual projects. The selection process occurs during the consultation phase preceding installation work.

The project assessment policy positions consultations as the initial step in sod projects. During consultations, TurnKey Sod personnel evaluate properties, discuss preferences with property owners, and identify sod options matching project requirements. The consultation phase establishes project parameters before sod selection and installation activities commence.

TurnKey Sod operates across multiple service areas within the Louisiana region. Coverage extends to Baton Rouge, Covington, Gretna, Hammond, Harahan, Kenner, Laplace, Madisonville, Mandeville, Metairie, River Ridge, Slidell, and St. Rose. The New Orleans metropolitan area represents the primary operational base for the company.

Sod installation involves ground preparation followed by sod placement according to project specifications. Installation duration varies based on lawn size, with projects ranging from several hours to multiple days depending on scope. TurnKey Sod handles installation for both residential lawns and commercial property landscapes.

Sod replacement addresses existing lawns requiring turf removal before new sod installation. The replacement process removes old sod materials before preparing the ground surface for new installation. This service category addresses properties with damaged or deteriorated existing turf conditions.

Sod delivery operates as a standalone service category for customers requiring sod materials without installation services. The delivery function transports sod from supply sources to project locations. Landscapers and contractors utilize the delivery service for projects where separate installation arrangements exist.

TurnKey Sod maintains operating hours Monday through Saturday from 8:00 AM to 5:00 PM. The company handles projects for homeowners, landscapers, and contractors as distinct customer categories. Homeowner projects typically involve residential lawn installation or replacement. Landscaper projects involve sod supply for landscape design implementations. Contractor projects address sod requirements within broader construction or development work.

Post-installation maintenance represents a component of the TurnKey Sod consultation process. The company provides guidelines on watering, mowing, fertilization, and care practices applicable to newly installed sod. Maintenance guidance addresses the specific requirements of each grass variety to support turf establishment following installation.

The project assessment policy enables property owners to receive information on project scope, grass variety recommendations, timeline estimates, and cost projections before committing to sod services. TurnKey Sod conducts assessments for residential and commercial properties across its Louisiana service areas.
