This approach can provide greater certainty for all parties and may limit the need for formal dispute procedures.

Record-keeping also plays a significant role in construction projects. Site diaries, correspondence, progress reports, and meeting minutes can help parties track decisions and monitor performance. Maintaining records may clarify what has been agreed, how changes were introduced, and whether contractual requirements have been followed. These records can become important if different interpretations later emerge about events on site, instructions given, or time-related claims.

When disagreements arise, many construction contracts provide for structured steps to address them. Processes can include informal discussions, written notices, meetings between senior representatives, mediation, adjudication, arbitration, or court proceedings, depending on the terms of the contract and the nature of the issue. An understanding of these processes in advance may assist parties in responding in a systematic way if a dispute develops, and in selecting procedures that are proportionate to the complexity and significance of the matter.
