An 18-wheeler can weigh up to 80,000 pounds when fully loaded, compared to an average passenger vehicle weighing approximately 4,000 pounds. This significant difference means that occupants of smaller vehicles typically sustain the most serious injuries in these collisions.

Recent settlements in trucking accident cases across Georgia have ranged from several million to nearly ten million dollars, reflecting the serious nature of injuries and long-term impacts on victims' lives. These settlements often cover medical expenses, lost wages, rehabilitation costs, and compensation for pain and suffering.

The firm has offices in Albany, Athens, Atlanta, Augusta, Columbus, Duluth, Macon, Savannah, and Valdosta, providing statewide coverage for accident victims.
