Without experienced legal counsel who understands these complexities, victims may receive far less compensation than they need for their medical bills, lost wages, and long-term care."

The firm's approach to 18-wheeler accident cases includes immediate investigation and evidence preservation, recognizing that crucial evidence such as driver logs, black box data, and surveillance footage can disappear quickly after an accident. Their legal team works to identify all potentially liable parties, which may include the truck driver, trucking company, cargo loaders, maintenance providers, or vehicle manufacturers.
