



## **Guthrie & Sons Expands Service Coverage into Clairemont Neighborhood**

The company has a long-standing practice of periodically reviewing its service coverage to ensure it reflects

actual operational conditions. Neighborhoods are identified based on consistency of activity, access routes, and scheduling efficiency. Clairemont, with its sizeable residential footprint and diverse property types, reached the internal benchmarks used to warrant formal inclusion.

This update is not part of a promotional rollout or marketing campaign. It does not involve changes to pricing, service structure, or customer programs. Instead, the change is limited to how the company documents and communicates its areas of coverage internally and publicly.

Clairemont's housing landscape presents a range of structural formats that influence installation logistics and service routing. Many homes date back to the post-war housing boom, and the neighborhood has since evolved to include a mix of modern infill projects and older units with varying system configurations. The service needs of such areas often require adaptable scheduling and an understanding of neighborhood-specific infrastructure.

Guthrie & Sons reports that the decision to name Clairemont as a service area follows the same framework used for other neighborhoods in recent years. These updates typically emerge from standard operations and are intended to provide greater clarity for internal teams and local residents alike.

The inclusion of Clairemont reflects an update to the company's internal service mapping. It does not involve adjustments to staffing, outreach plans, or the structure of services currently in place.

?Over time, some areas become more central to how we operate,? Guthrie said. ?Clairemont has been one of those places. It's not about expansion in a promotional sense?it's about accuracy in how we describe what's already underway.?

This update follows previous neighborhood adjustments made in other parts of San Diego, each rooted in the same approach. As the company continues to monitor its operations throughout the region, similar updates may occur in the future when patterns support them.

Clairemont is now included in the internal routing and geographic structure used by the company's scheduling and planning teams. This update is expected to remain in place as the company continues to serve a wide range of communities throughout San Diego County.
