Recent Supreme Court rulings have invalidated automatic renewal clauses attempting to extend beyond this period, creating uncertainty for long-term investment strategies. Informal or outdated ownership structures pose increasing risks as enforcement mechanisms strengthen.

"The year 2026 represents a turning point for legal compliance in Phuket real estate transactions," states Omar O Manee, Senior Property Lawyer at Siam Legal Phuket. "We are seeing a maturation of the market where regulatory authorities are implementing more sophisticated monitoring systems. Buyers who prioritize proper legal structuring from the outset will be best positioned to protect their investments and avoid costly disputes down the line."

The Thai government's proposed extension of lease terms from 30 to 99 years remains under legislative review, while the Board of Investment prepares to implement stricter rules on land ownership privileges for foreign businesses starting September 2025. These developments could significantly affect corporate property holding structures commonly utilized by international investors.
