



## **Siam Legal International Clarifies LTR Visa Thailand Tax Exemption Allowing 0 Percent Tax on Foreign Income**

Siam Legal International, a leading Thailand-based law firm, is providing essential guidance on how the Long-Term Resident (LTR) visa enables qualifying foreign nationals to legally remit overseas income into Thailand without paying Thai personal income tax, addressing growing concerns about recent changes to foreign income taxation rules.

The clarification comes as Thailand's Revenue Department has tightened its interpretation of tax regulations, now potentially taxing foreign-source income remitted into Thailand regardless of when it was earned. This shift has created uncertainty among expatriates, retirees, and remote workers who maintain income streams from abroad while residing in Thailand.

The LTR visa program, a 10-year residency initiative designed to attract high-potential foreigners to Thailand, offers a significant exemption from these tax obligations for certain categories of visa holders. The visa provides an initial five-year period, renewable once for another five years if qualifications are maintained, along with lifestyle benefits including fast-track airport services, annual reporting instead of 90-day reporting,

and digital work permits.

"The LTR visa represents a strategic solution for individuals seeking long-term residency in Thailand while maintaining favorable tax treatment on their foreign income," said Rex Baay, senior legal advisor at Siam Legal International. "Understanding the specific exemptions available under this program has become crucial as Thailand updates its approach to taxing foreign-source income."

Under Thai tax law, individuals staying in Thailand for 180 days or more in a calendar year become Thai tax residents. The recent interpretation changes mean that foreign-source income including salaries, pensions, dividends, rental income, interest, and investment returns, may be subject to Thai tax when remitted into the country.

However, three categories under the LTR visa program qualify for complete exemption from Thai tax on eligible foreign-source income: Wealthy Global Citizens, Wealthy Pensioners, and Work From Thailand Professionals. A fourth category, Highly Skilled Professionals, receives a separate benefit through a flat 17 percent tax rate on qualifying Thai employment income.

The Wealthy Global Citizen category accommodates high-net-worth individuals earning income primarily from overseas investments, dividends, and rental properties. The Wealthy Pensioner category serves retirees receiving stable pensions from abroad, while the Work From Thailand Professional category supports individuals working remotely for overseas employers or clients.
