their property and the scope of damage sustained.

Reconstruction needs following property damage often include structural repairs, drywall replacement, flooring installation, and other work required to return a space to its original condition. The company's rebuild division addresses these requirements while maintaining coordination with insurance claims processes, which the company already assists clients in navigating.

Zach Lord, Owner of RestoPros of Fairfield County, addressed the reasoning behind the service expansion. "Adding rebuild capabilities was a natural progression for us," Lord said. "When families are dealing with property damage, having one team handle everything from the initial response through final repairs can reduce stress and help them get back to normal faster."

The family-owned business operates around the clock, offering emergency response services throughout Fairfield County. The company's service model emphasizes rapid response times, with technicians typically arriving within 45 to 60 minutes of an emergency call. This operational structure now extends to the reconstruction phase, where project coordination begins as soon as mitigation work concludes.

Property damage events often create cascading challenges for homeowners and business owners alike. Water intrusion from burst pipes or flooding can lead to mold growth if not addressed promptly, while fire damage frequently involves smoke remediation alongside structural concerns. By maintaining oversight of both the remediation and rebuild phases, the company aims to address these interconnected issues through a unified approach.

The reconstruction services complement the company's existing capabilities, which include water damage restoration for basements, crawl spaces, and various plumbing failures, as well as mold remediation and fire damage restoration.
