



## **Siam Legal International Provides Guidance on New Tax ID Application Support for Thailand Privilege Members**

As a result, obtaining a Thai tax identification number is becoming increasingly important for long-stay foreign residents, even in cases where no immediate tax liability exists.

The Thailand Privilege program, formerly known as Thailand Elite, has officially launched the Tax ID Application Support Service for members holding Bronze, Gold, Platinum, Diamond, and Reserve memberships. Through the Thailand Privilege concierge service, members may request assistance with document preparation and procedural guidance to help navigate the application process more efficiently.

While concierge support is available, applicants are still required to appear in person at the Thai Revenue Department due to the confidential nature of tax records. The service is designed to reduce administrative errors, prevent delays, and minimize misunderstandings during the application process, while maintaining compliance with regulatory requirements.

A Thai tax ID is no longer used solely for tax filing, said Rex Baay, Senior Consultant at Siam Legal International. Foreign residents increasingly need it to open or update bank accounts, purchase property, access government digital platforms, and meet broader compliance expectations tied to long-term residency in Thailand.
