Industry observers note that rural dispensaries play an important part in normalizing regulated cannabis

distribution and supporting local economies through tax revenues and employment. M66 Cannabis Co aligns with this framework by committing to community enrichment efforts consistent with statewide objectives and regulatory expectations.

Rural locations like Barryton benefit from local dispensaries that reduce travel needs while adhering to state guidelines.
