

## Court King Injury Law Announces Expanded Auto Collision Representation Across Additional Service Areas

According to the firm, the expanded coverage includes assistance for individuals harmed in crashes involving third-party negligence across city streets, arterial corridors, and regional highways in and around the Las Vegas Valley. In matters where heavy vehicles are involved, the team addresses records unique to commercial carriers and contractors, including maintenance logs, driver qualifications, telematics, and dispatch records. Where a public entity is implicated, claims and filing deadlines are handled in accordance with applicable statutes and notice requirements.

The service identifies several common categories of compensable loss that may be pursued under state law, subject to evidentiary support and case facts. These include medical treatment costs, therapy and rehabilitation, wage loss, and pain and suffering. The firm indicated that each claim proceeds only after confirming that the elements of negligence can be established and that the claimed damages are supported by medical records and other documentation. Where appropriate, expert testimony may be sought on issues such as accident reconstruction, biomechanics, vocational impact, and life care planning in higher-severity injury cases.

Court King Injury Law highlighted that the expansion also integrates claims arising from incidents that do not involve a two-vehicle crash but nonetheless occur in traffic or transportation settings. Examples include

collisions with pedestrians or cyclists in marked and unmarked crossings, roadway incidents connected to

harm, traumatic brain injury, premises incidents, and wrongful death claims. The firm stated that the

outcome, and that each matter will be evaluated on its own facts, including the circumstances of the event,

the severity of injury, and the presence of insurance coverage. Timelines can vary, the firm said, with some

matters resolving in claims practice and others requiring formal litigation or trial.

Court King Injury Law reiterated that the expansion aims to meet demand across multiple communities in

Southern Nevada. Residents in Henderson, Summerlin, and throughout Clark County may now access the

same intake, case evaluation, and litigation resources historically available near the firm?s base of operations

in Las Vegas. The firm described the initiative as an operational step designed to increase accessibility rather

than a marketing campaign, with an emphasis on consistent procedures and responsive communication from

first contact through resolution.

?Building a strong record early is essential,? Jordan Butler added. ?The goal is to position the case for a fair

result by identifying all responsible parties, confirming coverage, and preparing as if a jury will review the

evidence. That preparation drives informed negotiations and, when necessary, a clear presentation in court.?
