



Moment of Clarity Publishes New Resource Examining the Cost of SPRAVATO® Without Insurance

SPRAVATO®, the brand name for esketamine nasal spray, was approved by the U.S. Food and Drug Administration in 2019 for adults with treatment-resistant depression when used alongside an oral antidepressant. According to the National Institute of Mental Health, more than 21 million adults in the United States experience major depressive disorder each year, and a substantial portion do not respond adequately to first-line antidepressant medications. Peer-reviewed studies published in The American Journal of Psychiatry and JAMA Psychiatry have documented that esketamine can provide symptom reduction for some patients when administered under strict medical supervision. As clinical use has expanded, questions about affordability without insurance have become increasingly relevant.

The newly published resource explains that the cost of SPRAVATO® without insurance typically reflects several components, including the medication itself, clinical administration, required monitoring, and follow-up care. Because SPRAVATO® must be administered in a certified healthcare setting under the FDA-mandated Risk Evaluation and Mitigation Strategy, patients must remain under observation following each dose. Data from the Kaiser Family Foundation shows that specialty mental health treatments delivered in supervised clinical environments often involve higher direct costs than standard outpatient care, which can present barriers for people paying out of pocket.

This educational release aligns with the outpatient-focused mental health services offered through Moment of Clarity's mental health programs, which are detailed on their website. National research supports the importance of transparency around treatment costs. The Centers for Medicare & Medicaid Services and independent health policy organizations have emphasized that cost uncertainty is a documented barrier to mental health treatment initiation. Studies published in Health Affairs indicate that patients who understand expected expenses and care requirements are more likely to remain engaged in treatment, even when paying out of pocket. Educational resources that clarify pricing, therefore, play a

meaningful role in treatment access and adherence.

The article also places SPRAVATO® within a broader continuum of care rather than presenting it as a standalone intervention.
