



# 1Charlotte Workers Compensation Lawyers Highlights Alarming Rise in Motorcycle Accidents from Distracted Driving

1Charlotte Workers Compensation Lawyers reports that distracted driving has emerged as the leading cause of motorcycle accidents in Charlotte, accounting for 42 percent of all crashes involving motorcycles in 2024, according to Charlotte-Mecklenburg Police Department data.

The firm, which represents injured motorcyclists throughout the Charlotte metropolitan area, notes that cell phone use alone caused 168 motorcycle crashes in Charlotte during 2024. This represents a significant shift in traffic safety dynamics, as distracted driving has now surpassed both speeding and impaired driving as the primary threat to motorcycle riders.

Mecklenburg County recorded 487 total motorcycle crashes in 2024, marking a 9 percent increase from 447 crashes in 2023. These accidents resulted in 52 fatalities and 341 serious injuries requiring hospitalization. The statistics reveal that motorcycles represent only 3 percent of North Carolina registered vehicles but

account for 10 percent of traffic fatalities.

"The data shows a troubling pattern where drivers using electronic devices simply fail to see motorcycles until impact occurs," said a firm representative from 1Charlotte Workers Compensation Lawyers. "Accident reconstruction and cellphone records frequently reveal that drivers were actively engaged with their devices at the moment of collision, creating unique dangers for riders who have limited protection compared to occupants of passenger vehicles."

The analysis reveals that social media use while driving increased 23 percent year-over-year, contributing to the overall rise in distracted driving incidents. While speeding contributed to 31 percent of accidents with 151 crashes, and driving under the influence accounted for 18 percent with 88 crashes, the dominance of distraction-related crashes marks a fundamental change in road safety challenges.

Evening rush hour between 5 and 7 PM accounts for 34 percent of motorcycle crashes, with high-traffic corridors experiencing concentrated incident rates. The I-77 and I-485 interchange recorded 31 crashes in 2024, while Independence Boulevard saw 42 total accidents. Construction zones along Independence Boulevard contributed to 15 percent of crashes in that corridor.

North Carolina experienced a 12 percent increase in motorcycle fatalities from 2023 to 2024, while Charlotte's rate exceeded the state average at 15 percent growth. This upward trend underscores the need for increased awareness among all motorists about sharing the road safely with motorcycles.
