



## **Ross Moore Law Addresses Rising Car Accident Concerns in Marietta Following Traffic Safety Data**

Ross Moore Law is addressing growing concerns about car accident rates and dangerous intersections in Marietta, Georgia, as recent traffic safety data reveals over 4,500 crashes occurred in the city during 2022, according to the latest data from the Georgia Department of Transportation.

The comprehensive traffic data shows that 1,155 crashes in Marietta resulted in injuries or fatalities, affecting more than 1,617 people. The intersection at US-41 and Canton Road has been identified as the most dangerous location in the city, while weekday crashes occur 42 percent more frequently than weekend incidents. "Car accident victims in Marietta face significant challenges when dealing with insurance companies, particularly in cases involving distracted driving, unsafe lane changes, and intoxicated drivers," said Ross Moore, founder and attorney at Ross Moore Law. The data reveals concerning patterns in Marietta traffic safety. Unsafe lane changes were cited as the most common traffic violation in accidents, contributing to 26 crashes. Intoxicated driving caused 66 collisions, resulting in one death and 53 injuries. Morning commuting hours between 7 and 8 a.m. see elevated crash numbers, with afternoon peaks occurring around 2 p.m.

Cobb County, where Marietta is located, experienced 64 traffic fatalities in 2021. The broader metro Atlanta area, including Interstate corridors I-75, I-85, I-285, and Georgia 400, continues to experience high accident rates. Georgia reported 1,466 roadway deaths in 2024, with pedestrians accounting for 20.1 percent of fatalities.

Despite national trends showing a 6.3 percent decline in traffic fatalities during the first quarter of 2025 compared to the same period in 2024, Marietta residents continue facing significant accident risks on busy roadways and high-traffic intersections.
