



# What Cocaine Really Costs Floridians, According to Real Recovery Solutions

Several core pricing factors are outlined in detail. Supply and demand still shape the illegal drug market, with scarcity driving higher prices. Purity also plays a role, as stronger cocaine is often sold at a premium, even when it has been cut with other substances. Geography matters as well. Nearly 90 percent of the cocaine consumed in the U.S. is produced in Colombia and typically enters through Mexico, while port cities like Tampa may see lower prices due to reduced transportation costs. Law enforcement presence further affects pricing, as heightened enforcement often leads to increased risk and higher prices.

The blog also breaks down costs by form and quantity. Powder cocaine and crack cocaine differ in appearance, method of use, and average price. Powder cocaine typically averages around \$120 per gram for personal use, while crack cocaine averages closer to \$80 per gram. Larger quantities reduce the per-gram cost but introduce serious legal consequences. The article notes that possession of an ounce or more of cocaine in Florida can result in trafficking charges, tying financial cost directly to legal risk.

The closing section addresses why people often research cocaine pricing. "Most people either want to know if they're getting a fair price, or they want to know how much someone they care about is spending on coke." The blog emphatically states that cocaine's true cost extends far beyond money, affecting physical health, mental well-being, relationships, and long-term stability.
