



# **Amircani Law Lawyer Analyzes 2025 Traffic Safety Data as Atlanta Accident Victims Navigate 2026**

As 2025 concludes with 14 consecutive quarters of declining national traffic fatalities, metro Atlanta continues to face persistent safety challenges that create complex legal and insurance landscapes for accident victims entering 2026. Despite nationwide improvements, the region's five core counties recorded 425 traffic deaths and over 160,000 total crashes in recent data, highlighting the ongoing need for experienced legal guidance when accidents occur.

The contrast between national trends and local realities presents unique challenges for Atlanta residents. While federal data shows sustained improvement in traffic safety metrics through the third quarter of 2025, Atlanta averages more than three crashes per hour, with approximately 30,000 car accidents occurring annually within city limits alone. These statistics underscore the importance of understanding legal rights and insurance processes, particularly as infrastructure projects create both short-term construction zone risks and long-term safety improvements.

"While national traffic fatality trends show encouraging declines, Atlanta accident victims still face significant challenges navigating insurance processes and understanding their rights in 2026," said Maha Amircani, Attorney and Founder at Amircani Law Atlanta car accident lawyer. "The concentration of accidents on specific corridors like I-285, I-75, and I-85, combined with ongoing construction zones, means victims need experienced guidance to evaluate whether settlements adequately address medical expenses, lost wages, and ongoing treatment needs."

The Atlanta Regional Commission has allocated \$168 billion through 2050 for transportation improvements, yet these infrastructure investments create immediate hazards even as they promise future safety benefits. Multiple active construction zones on major interstates contribute to accident risks, while just 10 percent of Atlanta streets account for 50 percent of pedestrian crash fatalities. Additionally, 48 percent of pedestrian collisions occur within 150 feet of MARTA bus stops, demonstrating how concentrated accident patterns affect specific areas disproportionately.

For accident victims seeking legal representation, understanding the evolving safety landscape becomes crucial when pursuing compensation. Wrong-way crashes have increased 175 percent over the past decade, jumping from 16 fatalities in 2013 to 44 in 2022. Urban roads in Georgia show twice the fatality rate per mile driven compared to rural roads, while 61 percent of traffic fatalities occur in predominantly Black neighborhoods despite representing only 43 percent of census tracts.

These persistent challenges mean accident victims benefit from professional legal guidance when dealing with insurance companies and medical billing complexities. An Atlanta car accident lawyer can help victims understand policy coverage, communicate effectively with insurers, and determine appropriate compensation for injuries sustained in crashes. This becomes particularly important as infrastructure operates beyond design capacity on major corridors, creating conditions where accidents remain frequent despite overall safety improvements.
