



# 1Georgia Injury Lawyers Addresses Rising Workers Comp Claims Amid Georgia's Warehouse Industry Boom

1Georgia Injury Lawyers reports increased demand for workers' compensation legal services as Georgia's booming warehouse and logistics sector experiences injury rates nearly double the industry average at major fulfillment centers.

Georgia's transportation and logistics industry, generating \$107 billion in economic impact during 2023, has created 578,000 jobs statewide, representing one in nine positions across Georgia. The sector's 68 percent growth from 2010 to 2023 significantly outpaces the 52 percent national average, with the Port of Savannah processing 5.7 million TEUs in fiscal year 2025, marking an 8.6 percent year-over-year increase.

This rapid expansion has brought workplace safety challenges to the forefront. Amazon facilities, employing 39 percent of all U.S. warehouse workers in 2024, account for 56 percent of serious injuries in the industry. The injury rate at Amazon warehouses stands at 5.9 per 100 workers, nearly double the 3.0 per 100 rate at

non-Amazon facilities.

"The unprecedented growth in Georgia's logistics sector has created complex workplace safety challenges affecting thousands of warehouse workers," said a Firm Representative for 1Georgia Injury Lawyers. "Many injured workers face claim denials or pressure to return to work prematurely, often unaware that 70.6 percent of denied claims require litigation or attorney involvement to secure rightful benefits."

With over 150,000 logistics workers statewide and 85 percent of top global third-party logistics companies operating in Georgia, workplace injuries have become increasingly common. Musculoskeletal disorders, including sprains, strains, and muscle tears, represent the most frequent warehouse injuries, often resulting from production quotas and performance metrics. Additional hazards include forklift accidents and repetitive motion injuries.

The Georgia workers' compensation system provides medical care, disability payments, prescription coverage, physical therapy, and vocational rehabilitation for injured workers. However, nearly seven percent of all workers' compensation claims face initial denial. Georgia's maximum weekly benefit stands at \$800 for 2024 injuries, equaling two-thirds of average weekly wages.

Workers must report injuries within 30 days to employers, navigate medical panel restrictions, and manage insurance investigations. These procedural requirements often prove challenging without legal representation. A 1Georgia workers comp lawyer can assist injured workers through the complex claim filing process, particularly when facing denials or disputes.

"Understanding your rights and the procedural requirements becomes critical when dealing with workplace injuries," added the Firm Representative. "Prompt injury reporting and seeking legal consultation when facing claim denials can make the difference between receiving proper compensation and struggling with medical expenses and lost wages."
