



## **McDougall Law Firm Reports Beaufort County Traffic Accidents Exceed 15,000 Over Four-Year Period**

McDougall Law Firm, LLC released data today showing Beaufort County recorded 15,489 traffic accidents between January 1, 2020, and June 16, 2024, resulting in 103 deaths and 6,314 injuries. The analysis positions Beaufort as having the 11th highest car accident rate among South Carolina's 46 counties, coinciding with the county's 25.64 percent population increase since 2010.

The county's population reached 204,589 in 2025, maintaining a 1.39 percent annual growth rate. Through mid-2024, data showed 13 fatalities and 633 injuries, indicating sustained accident levels despite statewide improvements. South Carolina achieved a nine percent decline in fatal crashes in 2024, reaching the lowest level in seven years.

The intersection of Parris Island Gateway and Robert Smalls Parkway recorded 267 collisions during the four-year period, marking it as the county's most hazardous intersection. The county's top 10 most dangerous intersections accounted for 1,432 total accidents over the study period.

"The concentration of development along the Highway 278 corridor has created complex traffic patterns that require specialized understanding when accidents occur," said J. Olin McDougall, II, founding attorney at McDougall Law Firm. "Many residents involved in accidents are unaware of their rights under South Carolina's at-fault insurance system, particularly regarding compensation for medical expenses and lost wages."

The Hilton Head Island-Bluffton-Port Royal metro area population reached 232,523 in 2023, with continued growth projected through 2026. The region's tourism and retirement-based economy creates seasonal population fluctuations that affect traffic patterns throughout the year.

Development concentrated in western Beaufort County has increased vehicle density at key intersections. The sustained nature of traffic incidents reflects infrastructure challenges as the county accommodates both permanent residents and seasonal visitors.
