He added that the firm periodically reviews public guidance and statutory amendments to determine when explanatory materials should be revised to remain current.

The overview includes background on benefit categories recognized under New York law, such as temporary and permanent disability classifications, without assigning monetary values or predicting outcomes. It also describes how medical providers, insurers, and employers interact within the system, emphasizing the procedural obligations assigned to each participant. By focusing on structure rather than results, the document is intended to function as a general reference rather than individualized legal advice.

Markhoff & Mittman, P.C. reports that its workers' compensation practice regularly monitors legislative and regulatory activity affecting claim administration. This monitoring includes reviewing published decisions, rulemaking notices, and administrative bulletins issued by state authorities. When substantive changes occur, the firm evaluates whether its publicly available materials require revision to reflect updated procedures or terminology.
