Chapman Highway and Western Avenue each saw two fatal crashes in 2025, underscoring ongoing risks in these areas.

Tennessee follows a modified comparative negligence rule, allowing pedestrians to recover damages if less than 50% at fault for an accident. This legal framework, combined with the one-year statute of limitations for pedestrian accident claims, creates urgency for victims to seek legal counsel immediately after incidents.
