



## **WCL ATL Workers Compensation Lawyer Coalition Addresses Impact of March 2026 Georgia Rate Decrease on Injured Workers**

The Workers Compensation Lawyer Coalition reports that the National Council on Compensation Insurance has filed for an 8.8 percent decrease in Georgia workers compensation loss costs effective March 1, 2026, marking a significant shift in the state's workers compensation landscape that will affect both employers and injured workers throughout Clarke County and the Athens area.

The rate filing, based on premium and loss experience data from policy years 2022 and 2023, includes a 9.3 percent decrease proposed for assigned risk market rates. While these reductions reflect improving workplace safety trends across Georgia, the complexity of workers compensation claims continues to challenge injured workers navigating the system.

"The rate decrease demonstrates positive safety trends in Georgia workplaces, but injured workers still face significant challenges when pursuing compensation claims," stated a spokesperson for the Workers

Compensation Lawyer Coalition. "With claim severity increasing for both medical and wage replacement components in 2024, workers need experienced legal guidance to ensure they receive the full benefits available under Georgia law."

The WCL ATL Athens workers compensation lawyer network emphasizes that injured workers must understand their rights and responsibilities under Georgia law. Reporting requirements mandate that employees notify their employer of workplace injuries promptly, with specific deadlines affecting benefit eligibility. The claims process involves multiple steps, including medical treatment authorization, disability determinations, and potential disputes requiring legal expertise.

The rate changes arrive as Georgia's workers compensation system continues evolving following 2023 legislation that increased maximum weekly benefits from \$725 to \$800 per week. Current maximum temporary total disability and permanent partial disability rates stand at \$800 per week, while temporary partial disability rates cap at \$533 per week. Benefits begin after a seven-day waiting period for injured employees.

Despite declining claim frequency indicating safer workplaces, Georgia experienced 192 fatal workplace injuries in 2023, according to Bureau of Labor Statistics data. The construction sector recorded the highest number of fatalities with 37 deaths, while transportation and material moving occupations saw 56 fatal workplace injuries statewide.

For Athens area employers, the rate decrease may reduce insurance costs, but workplace accident risks remain substantial across local industries, including manufacturing, construction, healthcare, retail, and transportation. Each sector presents unique injury risks requiring comprehensive workers compensation coverage and proper claims management.
