Under Louisiana law, armed robbery is the taking of anything of value belonging to another from the person of another, or from that person's immediate control, by use of force or intimidation while the offender is armed with a dangerous weapon. The offense carries severe penalties, including a mandatory prison term of ten to ninety-nine years at hard labor, without benefit of parole, probation, or suspension of sentence, and when a firearm is used during the crime, the law authorizes the court to impose an additional consecutive term of five years at hard labor without benefits when the statutory requirements for a firearm enhancement are established. In a criminal justice climate marked by heightened public safety concerns and strict

sentencing for violent offenses, individuals accused of armed robbery need experienced legal counsel who can navigate complex statutes and help protect their constitutional rights throughout the process.
