



# **Siam Legal Phuket Addresses Legal Risks as Authorities Renew Scrutiny of Illegal Nightlife Operations**

Siam Legal Phuket has issued guidance for entertainment and hospitality operators following renewed concerns about illegal nightlife operations and licensing compliance challenges across Phuket's tourism sector. The legal firm's advisory comes as nightlife operators in Patong and other areas have urged authorities to crack down on illegal entertainment venues and unlicensed accommodation providers.

The issue resurfaced following complaints filed with the Damrongdham Centre concerning alleged bribery involving entertainment operators during the New Year holiday period. While authorities later stated there was insufficient evidence to substantiate the allegations, these recurring concerns about informal practices in major tourist destinations highlight the importance of transparent compliance systems and access to proper legal guidance.

Siam Legal Phuket notes that some operators intentionally violate regulations by operating beyond permitted

hours or without valid licenses. While only properly licensed venues in designated areas of Patong are permitted to operate until 4 AM, enforcement challenges persist. Industry feedback suggests that complicated, slow, or unclear licensing processes contribute to non-compliance and informal practices, exposing businesses to significant legal and operational risks.

"The complexity of Thailand's entertainment licensing framework creates substantial challenges for both local and foreign business operators," stated Omar O Manee, Senior Legal Advisor at Siam Legal Phuket. "When businesses operate without proper licenses or exceed permitted hours, they face not only immediate penalties and potential closure but also long-term reputational damage that can severely impact their viability in Phuket's competitive tourism market."

Illegal operations undermine fair competition and deprive the government of legitimate tax revenue at a time when the tourism sector is already under economic pressure. Entertainment businesses reported weaker performance during the recent high season due to reduced tourist spending. Visitor demographics were primarily from India, Europe, and Russia, while the Chinese tourism market remained subdued, adding further strain to an already challenging business environment.
