Research examined by the firm indicates that altitude can affect performance on all three components of the Standardized Field Sobriety Test battery: the horizontal gaze nystagmus test, the walk-and-turn test, and the one-leg stand test. Visitors to Colorado often experience altitude sickness symptoms within hours of arrival, including headaches, fatigue, and impaired balance, which persist for several days as their bodies acclimate.
