



## **Siam Legal Phuket Advises Foreign Investors on Compliance Amid Immigration Arrests and Business Enforcement**

Siam Legal Phuket has issued guidance for foreign residents and investors following recent Thai immigration arrests involving fraud suspects and intensified enforcement actions targeting illegal nominee business structures in Thailand's resort areas.

Thai immigration authorities have detained multiple foreign nationals wanted overseas for fraud charges, with cases involving visa revocations and cross-border coordination with foreign embassies. Recent arrests include a Chinese national sought for investment-related fraud and a Japanese national wanted in connection with an online forex scheme. In both cases, authorities revoked visas immediately and placed the individuals in detention pending extradition proceedings.

The enforcement actions extend beyond individual arrests to include heightened scrutiny of corporate structures, with authorities investigating companies allegedly using Thai nominees to conceal foreign

ownership. These investigations particularly target luxury villa rental and sales operations that cater to foreign clients, where both Thai nominee shareholders and foreign operators may face potential criminal liability.

"The current enforcement environment reflects Thailand's commitment to international cooperation on financial crimes while simultaneously protecting the integrity of its business ownership laws," said Omar O Manee, Senior Legal Advisor at Siam Legal Phuket. "Foreign investors need to understand that improper business structures and visa misuse carry serious legal consequences that can result in deportation, asset seizure, and criminal prosecution."

The law firm notes that enforcement actions against foreign fraud suspects and nominee business structures have intensified as Thai authorities strengthen nationwide monitoring systems and enhance coordination with international law enforcement agencies. Immigration officials are increasingly tracing assets linked to detained suspects and expanding investigations into related business networks.

For foreign residents in Phuket and other resort destinations, these developments underscore the importance of maintaining proper visa status and ensuring that business operations follow Thai ownership regulations. Thailand's Civil and Commercial Code strictly limits foreign land ownership, and attempts to bypass these restrictions through nominee arrangements may constitute violations of both civil and criminal law.
