



## **KEGE Center for ADHD Continues to Expand Access to Structured ADHD Evaluations Across Arizona**

KEGE Center for ADHD announced the continued expansion of access to its structured ADHD evaluation services for patients across Arizona, reflecting sustained demand for clear diagnostic processes and coordinated care. The psychiatric practice provides evaluations through its Gilbert office as well as secure online visits available statewide, allowing individuals and families to seek assessment without geographic barriers.

The announcement highlights the organization's ongoing focus on standardized ADHD evaluations conducted by board-certified providers. The evaluation process is designed to support diagnostic clarity through structured clinical interviews and validated screening tools, with careful documentation used to guide clinical decision-making. According to the practice, consistent evaluation standards help ensure that patients receive the same level of review regardless of whether services are accessed in person or online.

Medication management is provided when indicated, with follow-up visits used to monitor response and adjust plans as needed. When additional counseling support is recommended, providers refer patients to trusted outside therapists and continue to coordinate ADHD care to support continuity over time.

For pediatric patients between the ages of six and twelve, the KEGE Center for ADHD may use the KEGE Bridge as part of the evaluation process when appropriate. KEGE Bridge is a secure system for gathering teacher or caregiver feedback to strengthen diagnostic accuracy. The practice reported that structured input from school and home settings can provide helpful context during assessment.

The organization also continues to use KEGE Connect, a patient portal that supports appointment scheduling, secure messaging, and medication refill coordination. The portal is intended to reduce administrative barriers while allowing providers to maintain consistent communication with patients and families throughout care. The practice noted that reliable access to communication tools supports follow-up consistency and reduces delays between visits.

In recent years, the KEGE Center for ADHD has observed increased interest in ADHD evaluations among adults seeking assessment later in life, as well as families looking for clearer guidance for school-aged children. Public health data continue to show that ADHD remains one of the most commonly evaluated neurodevelopmental conditions, with many individuals reporting difficulty accessing timely and structured assessments.

The practice stated that maintaining standardized evaluation procedures is especially important as virtual care continues to expand. Providers noted that clear processes help ensure online evaluations remain clinically grounded and consistent with established diagnostic practices, regardless of appointment format.

Patient feedback continues to be reviewed as part of ongoing quality monitoring. Verified public data reflects over 250+ reviews with a 98 percent five-star rating. While outcomes vary by individual, the organization reports that clarity of communication and consistency of care processes are frequently referenced themes.

KEGE Center for ADHD also noted that evaluations are scheduled with attention to reducing unnecessary

wait times while maintaining clinical thoroughness. The practice accepts many major insurance plans and continues to review scheduling workflows to support timely access for new and returning patients.

Providers continue to emphasize consistency in assessment while adapting scheduling workflows to support timely care across Arizona.

The organization emphasized that its services remain focused exclusively on ADHD evaluation and management. KEGE Center for ADHD does not provide therapy directly and continues to coordinate care through referrals when additional counseling is recommended. All services are available only to Arizona residents, either through the Gilbert office or online throughout the state.

As demand for ADHD evaluations continues statewide, the KEGE Center for ADHD stated that it will continue reviewing internal processes to support clarity, access, and coordination. No changes were announced regarding provider structure, service scope, or geographic availability.
