Changes to South Carolina's probate code have expanded eligibility for simplified estate processes, affecting residents throughout the Lowcountry, according to The Fraser Law Firm, LLC?effective May 8, 2025, Act No. 26 (H.3472) raised small-estate and exempt-property limits to \$45,000.

"Recent probate law changes provide Lowcountry families with more efficient options for handling estates, including collection by affidavit for certain small estates where statutory conditions are met," said Denny Fraser, founding attorney of The Fraser Law Firm, LLC. "Small-estate procedures can streamline debt settlement and asset distribution with reduced court oversight for qualifying estates, while exempt-property rules protect up to \$45,000 in household goods, vehicles, and personal effects for surviving spouses and minor children, with priority over all claims except those listed in §62-3-805(a)(1)."

These probate updates often intersect with active real estate markets in Bluffton and Hilton Head, where property transfers frequently prompt estate document reviews. The region includes communities such as Sun City Hilton Head and Palmetto Bluff, which continue to attract retirees.

Where applicable, collection-by-affidavit can reduce paperwork for personal property without opening a full estate?it does not transfer real estate?and applies only when (i) the probate estate?s value, less liens and encumbrances, does not exceed \$45,000; (ii) at least 30 days have elapsed since death; and (iii) no application or petition to appoint a personal representative is pending or granted; the affidavit must also be approved and countersigned by the probate judge.
