## David Benn Obtains Florida's Largest Q4 2025 Workers' Compensation Decision

Florida Attorney Secures \$1.45 Million Workers' Compensation Decision, Highest Q4 2025 Payout in State

Workers' compensation attorney David Benn obtained a \$1,450,000 decision for his client on December 15, 2025, representing the largest workers' compensation payout awarded in Florida during the fourth quarter of 2025, according to state compensation board records.

The decision was reached through Florida's workers' compensation administrative system, which processes thousands of injury claims annually for workers across the state. Workers' compensation cases in Florida are handled through the State Board of Workers' Compensation rather than traditional civil court proceedings.

"This outcome demonstrates that thorough case preparation and aggressive advocacy can achieve fair compensation for injured workers," said David Benn, Managing Partner at WorkInjuryRights.com. "Our client deserved full benefits under Florida law, and we ensured they received them."

The \$1.45 million decision addresses the full scope of benefits available under Florida workers' compensation

law, which can include medical treatment costs, wage replacement during recovery, permanent disability benefits, and vocational rehabilitation expenses. Florida law requires most employers with four or more employees to carry workers' compensation insurance.

Benn has practiced workers' compensation law exclusively since 2010, handling cases throughout Florida's judicial districts. Prior to representing injured workers, he worked as defense counsel for employers and insurance companies in workers' compensation claims. This background provides insight into the defense strategies insurance carriers commonly employ to minimize payouts or deny claims entirely.

Benn is a member of the Florida Bar and is proficient in Spanish, serving clients throughout South Florida, where he has resided since 2005. His practice focuses on securing medical benefits, wage replacement, and long-term disability support for workers injured on the job.

Workers' compensation claims in Florida often face challenges during the administrative process. Insurance carriers may dispute the severity of injuries, question whether injuries occurred at work, or attempt to reduce benefit amounts. Injured workers frequently encounter claim denials or delayed payments, making legal representation critical to securing appropriate benefits.
