



# **Ross Moore Law Addresses Georgia's 81 Percent Surge in Truck Accident Fatalities Impacting Marietta Motorists**

Georgia's truck accident fatalities have surged 81 percent over the past decade, with the state recording 8,406 commercial vehicle crashes in 2024 alone, ranking fourth highest nationally. This alarming trend particularly affects motorists traveling through Marietta's heavily trafficked I-75 corridor, where multiple fatal commercial vehicle crashes have occurred in recent months.

The statistics reveal a concerning pattern for Georgia drivers. In 2023, the state experienced 257 truck fatalities, the highest number in a decade, among 50,344 total truck crashes. Between 2013 and 2023, Georgia recorded 310,746 total truck crashes resulting in 2,374 fatalities. These numbers reflect Georgia's position as a major logistics hub, with over 5 million truck registrations, ranking eighth nationally.

Marietta's location along the critical I-75 freight corridor connecting Atlanta to Tennessee places local motorists at elevated risk. Cobb County's stretch of I-75 has witnessed multiple fatal commercial vehicle

incidents, including an August 2025 hit-and-run death near South Marietta Parkway and a February 2025 underride crash that claimed additional lives.

"Commercial vehicle accidents present unique legal complexities that standard car accident cases don't involve," stated Ross Moore, founding attorney at Ross Moore Law. "Federal trucking regulations, multiple potentially liable parties including drivers, trucking companies, maintenance contractors, and cargo loaders, plus corporate defendants with substantial legal resources, make these cases particularly challenging for accident victims to navigate alone."

The increase in truck traffic through Marietta corresponds with Georgia's growing role in national freight distribution. The I-75 corridor serves as a primary artery for commercial vehicles traveling between major southeastern cities, creating constant interaction between passenger vehicles and large trucks during daily commutes.

The legal complexities surrounding commercial vehicle accidents require specialized knowledge of federal transportation regulations, insurance requirements, and corporate liability structures that differ significantly from standard automobile accident cases.

"Marietta residents traveling I-75 need to understand both the heightened accident risks on this freight corridor and their legal rights if involved in a collision," Moore explained. "The disparity in size and weight between commercial trucks and passenger vehicles often results in catastrophic injuries requiring extensive medical treatment and long-term care."

Evidence preservation, including electronic logging device data, maintenance records, and driver qualification files, requires prompt action to protect victims' rights.
