"However, appropriate legal structures remain critical for secure property ownership, particularly for expatriates who must navigate Thailand's specific regulations on foreign property ownership."

Thai law strictly regulates foreign property ownership, particularly regarding land ownership, making professional legal guidance essential for successful acquisitions. Foreign nationals cannot directly own land under current regulations, but can purchase condominium units or enter into leasehold agreements. Standard lease terms are limited to 30 years under the Civil and Commercial Code, with recent Supreme Court rulings invalidating automatic renewal clauses that attempt to extend beyond this period.

The Thai government has proposed extending lease terms from 30 to 99 years to attract more foreign investment, though these reforms await legislative approval. Additionally, the Board of Investment plans to implement stricter rules on land ownership privileges for foreign businesses starting September 2025, potentially affecting corporate property holding structures commonly used by international investors.

Siam Legal Phuket emphasizes that foreign buyers should confirm ownership structures, verify title deeds, and assess developer credibility before committing funds. Property acquisition involves both civil rights, such as ownership and usage rights, and ongoing financial responsibilities, including taxes, maintenance, and management rules. Misunderstandings around ownership limits or improper documentation can lead to prolonged disputes or financial exposure.
