Work injury law in New York is primarily governed by the state's workers' compensation system, which provides medical coverage and wage replacement benefits to employees injured in the course of

employment. Claims are administered through a structured process that includes medical documentation, employer reporting, and review by the Workers' Compensation Board. Disputes may arise regarding the extent of injury, eligibility for benefits, or the duration of authorized treatment.
