



The Weinstein Firm Comments on FMCSA Revocation of Electronic Logging Devices Affecting Truck Safety

The Federal Motor Carrier Safety Administration revoked four electronic logging devices on January 13, 2026, requiring carriers to replace PREMIERRIDE LOGS, DSGELOGS, STATE ELOGS, and STATE ELOGS 2 by March 15, 2026. The enforcement action raises important questions about truck accident liability and safety compliance on Georgia highways, where 244 people died in truck crashes in 2021.

Electronic logging devices automatically record driving hours to ensure commercial drivers comply with federal hours-of-service regulations designed to prevent fatigue-related crashes. The revoked devices no longer meet federal standards for accurately tracking driver hours, potentially compromising the safety data needed to prevent accidents.

"When trucking companies use non-compliant electronic logging devices, they create gaps in the safety records that protect everyone on the road," said a spokesperson for The Weinstein Firm Decatur truck accident lawyer. "After the March 15 deadline, carriers continuing to use these revoked systems may face

heightened liability if their drivers are involved in accidents, particularly when hours-of-service violations contributed to driver fatigue."

The timing of the FMCSA enforcement action is significant for Georgia, where large trucks represent a major factor in traffic fatalities. The state recorded 1,797 total traffic deaths in 2022, with commercial vehicles playing a substantial role. Nationwide statistics underscore the severity of truck accident risks, with 5,472 people dying in large truck crashes in 2023 and over 125,000 suffering injuries annually in commercial truck accidents.

The revocation affects trucking companies operating through Decatur's major freight corridors, including Interstate 20 and Interstate 285. These highways experience heavy commercial traffic, and DeKalb County reported approximately 30,000 crashes in 2021. The concentration of truck traffic through these corridors makes ELD compliance particularly important for local safety.

Decatur truck accident lawyer representatives note that ELD records serve as critical evidence in accident investigations. The devices track when drivers exceed legal driving limits, take required breaks, and comply with mandatory rest periods. This data becomes essential when determining liability in truck accident cases, particularly when establishing whether driver fatigue or hours-of-service violations contributed to a crash.

Trucking companies face potential consequences beyond regulatory fines if they fail to replace the revoked devices. Insurance carriers may dispute coverage for accidents involving non-compliant vehicles, and plaintiff attorneys can use regulatory violations to establish negligence in civil litigation. The March 15 deadline gives carriers two months to upgrade their systems and ensure compliance with federal safety standards.

The enforcement action reflects broader federal efforts to strengthen commercial vehicle safety through technology oversight. ELDs replaced paper logbooks in 2017 to create tamper-resistant records of driver activity. The FMCSA regularly reviews approved devices to ensure they meet evolving safety standards and provide accurate data for enforcement and accident investigation purposes.

Of particular concern is the disproportionate impact of truck accidents on passenger vehicle occupants. Seventy-six percent of fatalities in commercial truck accidents involve occupants of other vehicles rather than truck drivers themselves, highlighting the importance of strict compliance with safety regulations designed to protect all road users.
