



NC Injury Law Addresses North Carolina's Harsh Contributory Negligence Rule Affecting Thousands of Accident Victims

With the state averaging 276,026 crashes annually resulting in over 74,000 injuries and 1,653 fatalities, the firm emphasizes the critical need for experienced legal representation to navigate this challenging legal landscape.

North Carolina remains one of only four states maintaining the strict contributory negligence doctrine, creating unique challenges for accident victims seeking fair compensation. The rule allows insurance companies to deny entire claims if they can prove a victim contributed even minimally to an accident, regardless of the other party's degree of fault.

"Insurance companies routinely exploit North Carolina's contributory negligence law to deny legitimate claims

by arguing victims were even one percent at fault," stated Thomas York, lead attorney at NC Injury Law with over 30 years of experience. "Something as simple as saying 'I'm sorry' at an accident scene can be weaponized to deny compensation entirely, even when the other driver bears overwhelming responsibility for the crash."

The statistics paint a concerning picture for North Carolina drivers. The state experiences approximately 756 crashes per day, with 204 resulting in injuries and four proving fatal. Young drivers aged 20-29 account for 27.2 percent of all crashes, while nearly 25 percent of fatal accidents involve speeding. Distracted driving contributes to 17.9 percent of crashes, though experts believe this figure is underreported.

Wilmington faces particular challenges, ranking 14th worst for driver safety among 95 similarly-sized cities in 2021. The city's most dangerous corridors include College Road, Market Street, and Carolina Beach Road, where many serious accidents occur during peak hours between 7 AM and 7 PM, when 70 percent of all crashes happen statewide.
