



## **Atlanta Accident Lawyers Responds to Latest Traffic Safety Data Showing Continued Need for Car Accident Lawyer Representation in Georgia**

The National Highway Traffic Safety Administration reported a 6.3 percent decline in traffic fatalities during the first quarter of 2025 compared to the same period in 2024, with the fatality rate dropping to 1.05 deaths per 100 million vehicle miles traveled, the lowest quarterly rate since early 2019.

While these statistics represent positive progress in road safety, Georgia continues to face significant challenges. The Georgia Department of Transportation reported 1,466 roadway deaths in 2024, with 367,523 total traffic accidents injuring over 143,000 people. Additionally, 62 percent of Georgia traffic fatality victims in 2024 were unbelted or belt use was unknown according to GDOT Drive Alert Arrive Alive data, and 20.1 percent of the state's 2024 traffic fatalities were pedestrians.

"Despite encouraging trends in traffic safety, the sheer volume of accidents in Georgia and the complexity of our state's at-fault insurance system mean that accident victims still face significant legal challenges," said Shannon Ludwig, spokesperson for Atlanta Accident Lawyers car accident lawyer services. "With Georgia's modified comparative negligence rule allowing injury victims to recover compensation only if they are less than 50 percent at fault, establishing liability becomes critical to securing fair compensation. Insurance companies often dispute fault to minimize payouts, making legal consultation extremely helpful during the critical evidence-gathering period following an accident."
