



Siam Legal Chiang Mai Warns of Legal Risks Following Arrests Over Falsified Residency Documents

Siam Legal Chiang Mai has issued a legal advisory following the arrest of six government officials, including two deputy district chiefs, in connection with the alleged falsification of permanent residency and population registration documents in Chiang Dao district. The law firm emphasizes the serious legal consequences for foreign nationals who may unknowingly rely on improperly issued documentation.

The arrests, conducted by the Central Investigation Bureau, Anti-Corruption Division, and Department of Provincial Administration, represent part of a coordinated enforcement action targeting officials accused of abusing their authority to certify false residency and nationality documents. The Criminal Court for Corruption and Misconduct issued warrants for the arrests, reflecting heightened scrutiny of civil registration processes in Northern Thailand.

Investigators uncovered falsified permanent residency records, birth certificates, and related population registration documents during their investigation. These findings underscore a critical risk for foreign

residents, as fraudulent documentation can invalidate nationality status even years after issuance, potentially affecting individuals and families who have built their lives in Thailand.

The recent arrests follow an earlier investigation into bribery linked to citizenship applications for foreigners and stateless persons in the region. Authorities have confirmed that the investigation will expand to review additional civil registration records, marking this documentation integrity as a priority enforcement area for Thai immigration and nationality oversight.

"Foreign nationals seeking permanent residency or citizenship in Thailand must understand that these processes require strict adherence to legal and documentary requirements," said Apichart Mattayanuwat, Managing Partner at Siam Legal Chiang Mai. "Using falsified documents or engaging corrupt intermediaries, whether knowingly or unknowingly, exposes applicants to severe long-term legal risks including criminal prosecution and revocation of their legal status."

The officials arrested face charges including certifying false official documents, abuse of authority, and supporting falsified population records. Both officials who create fraudulent documents and applicants who use them may face criminal liability under Thai law. Moreover, Thai nationality obtained through improper means can be revoked at any time, leaving individuals and their families in legally vulnerable positions.
