Under Thai criminal law, individuals convicted of property damage may face penalties ranging from fines to imprisonment, depending on the severity and intent of the damage involved. The legal consequences extend beyond criminal sanctions. Immigration authorities may revoke or cancel visas, initiate deportation proceedings, and impose re-entry bans upon conviction. These measures can be enforced even in cases involving relatively minor property damage.

The firm further notes that leaving accommodation premises without addressing property damage allegations can significantly escalate the situation. What might begin as a manageable dispute can quickly transform into a formal criminal investigation, potentially resulting in arrest warrants issued for fleeing suspects. Holding a tourist or non-immigrant visa status provides no immunity from criminal prosecution under Thai law.
