



## **The Weinstein Firm in Marietta Addresses Georgia's Decade-High Truck Accident Crisis Following 257 Fatalities in 2023**

The data reveals that commercial trucks were involved in 14 percent of all Georgia traffic fatalities despite representing a much smaller percentage of vehicles on the road.

Georgia's commercial trucking safety crisis reached historic proportions in 2023, with 257 fatalities marking the highest death toll in a decade and representing an alarming 81 percent increase from the 142 deaths recorded in 2013. The state documented 50,344 truck-related crashes last year, the highest annual count in ten years, prompting legal experts to emphasize the critical need for experienced representation in these complex cases.

"The dramatic increase in truck accident fatalities reflects systemic safety failures across the industry," stated

a spokesperson from The Weinstein Firm. "With 86 percent of truck-related crashes involving multiple vehicles, Georgia families face unprecedented risks, particularly along corridors like I-75, I-85, and I-285 that run through communities including Marietta and greater Cobb County."

Georgia's position as the fourth-ranked state nationally for truck accident fatalities in 2021, with 244 deaths representing 4.2 percent of the US total, underscores the severity of the crisis. The post-pandemic years from 2021 to 2023 showed a sharp rebound in both crash counts and fatalities, with 2022 recording 260 truck fatalities, the decade's second-highest total.

Federal safety data compounds these concerns, as inspectors discovered over 50,000 violations across 8,340 trucking companies operating in Georgia. Transportation incidents accounted for 36 percent of all fatal workplace injuries in the state during 2023, highlighting the broader impact on worker safety.

The complexity of truck accident cases extends beyond typical vehicle collisions. Federal regulations, multiple potentially liable parties, and corporate investigation teams that often arrive at crash scenes create challenges for victims seeking fair compensation. A Marietta Truck Accident Lawyer must navigate intricate commercial vehicle laws, insurance policies, and corporate structures to protect victims' rights.

"These statistics represent real families devastated by preventable tragedies," added the spokesperson. "When a commercial truck accident occurs, victims face immediate pressure from insurance companies and trucking corporations while dealing with catastrophic injuries or loss. The identified dangerous corridors of I-75, I-85, and I-285 serve as major freight routes through metropolitan Atlanta, exposing residents of Marietta, Decatur, and surrounding communities to elevated risk levels. The concentration of commercial traffic through these areas contributes to the state's troubling safety record.


