



# **NC Car Accident Lawyers Documents 4,992 Commercial Vehicle Crashes as Raleigh Infrastructure Faces Growth Pressures**

The firm's analysis highlights infrastructure challenges as Wake County adds 53 to 66 new residents daily while freight corridors experience increased commercial traffic volumes.

Raleigh crossed 500,000 residents in 2024 according to S.T. Wooten, a Complete 540 construction partner, while the RTP/I-40 corridor and Eastern Wake County have emerged among the Southeast's most active industrial submarkets.

"Commercial truck accidents involve multiple liability considerations including drivers, trucking companies,

freight brokers, cargo loaders, and maintenance contractors," stated a firm representative for NC Car Accident Lawyers. "Electronic logging device data, which tracks Hours of Service compliance, can be overwritten within 30 days without formal preservation procedures."

The Regional Transportation Alliance has identified freight bottlenecks on I-40 as among North Carolina's most costly for commercial vehicle delays. Complete 540 Phase 2, a \$287 million expansion currently underway south and east of Raleigh, has created active construction zones at the I-40/I-42 interchange and several U.S. highway crossings, adding complexity to existing traffic patterns.

Federal Motor Carrier Safety Administration statistics indicate passenger vehicle occupants comprise 68 percent of truck crash fatalities, with North Carolina recording approximately 2,500 truck-related injuries annually. These figures reflect the physics of collisions between commercial vehicles weighing up to 80,000 pounds and passenger vehicles averaging 4,000 pounds.

North Carolina's contributory negligence standard presents specific legal considerations in commercial vehicle cases. Under this framework, any determination of shared fault can affect compensation eligibility, a factor that distinguishes North Carolina from comparative negligence states.

Commercial vehicle accidents differ from standard collisions due to federal regulations governing the trucking industry. Hours of Service requirements limit driving time to prevent fatigue-related accidents, while electronic logging devices create digital records of compliance. These devices replaced paper logbooks in 2017 under FMCSA mandate.

The trucking industry operates under multiple regulatory frameworks including Federal Motor Carrier Safety Regulations, state transportation codes, and insurance requirements ranging from \$750,000 to \$5 million depending on cargo type. These overlapping jurisdictions create complex liability determinations requiring analysis of driver logs, maintenance records, cargo manifests, and corporate structures.
