Many organizations include certified first aid and CPR personnel as part of broader safety and compliance programs. When a medical emergency occurs in the workplace, immediate response can influence outcomes, reduce operational disruption, and support internal reporting and risk control processes. Maintaining current certifications is a practical step for companies seeking to reinforce emergency action plans and maintain workforce readiness. For industries such as construction, manufacturing, and general industry, having trained personnel on-site is not only good practice but may be required under applicable OSHA standards, including 29 CFR 1910.151 for general industry and 29 CFR 1926.50 for construction.

Registration and event details for the March 17 session are available through the local first aid, CPR, and AED certification course listing. The instructor-led program prepares participants to recognize and respond to adult cardiac, breathing, and other medical emergencies. Individuals who successfully complete the course receive a digital certification valid for two years.
