Unlike programs that focus exclusively on the number on the scale, Rixa Health's approach emphasizes body composition ? specifically targeting visceral fat reduction while preserving lean muscle mass. Each patient receives a smart body composition scale that connects to Apple Health, Samsung Health, and Google Fit, enabling automatic tracking of metabolic changes between appointments.

The platform also monitors critical health indicators including blood pressure, glucose levels, and cardiovascular markers. Providers conduct regular virtual check-ins to review patient progress, adjust treatment protocols in real time, and address any side effects that may arise during the course of treatment.

Rixa Health differentiates its model from other telehealth providers by maintaining continuous medical support throughout the patient journey. Rather than issuing a prescription and ending engagement, the company's providers remain actively involved in refining each patient's protocol as their body responds to treatment.
