



KEGE Center for ADHD Emphasizes Coordinated Care Planning Following ADHD Evaluations

KEGE Center for ADHD announced continued emphasis on coordinated care planning following ADHD evaluations, reinforcing a structured approach to next steps after diagnosis. The psychiatric practice stated that clear follow-up planning remains a central part of its care model for patients evaluated in the Gilbert office or through secure online visits available throughout Arizona.

According to the organization, individuals seeking ADHD evaluations often report uncertainty about what happens after a diagnosis is made. KEGE Center for ADHD noted that its care process is designed to provide patients with a clear understanding of evaluation findings and how recommendations are developed. Board-certified providers conduct evaluations using structured clinical interviews and validated screening tools to support diagnostic accuracy.

When clinically appropriate, evaluations include screening for co-occurring conditions such as anxiety, mood concerns, insomnia, oppositional defiant disorder, and depression. The practice stated that screening information is used to inform coordinated care planning rather than as a standalone treatment determination. Providers emphasized that understanding overlapping symptoms is an important part of developing

appropriate next steps.

“Evaluation is only the starting point,” said Keith Getic, founder of KEGE Center for ADHD. “Patients need clear guidance after an assessment so they understand their diagnosis and how care will be coordinated moving forward.”

Following completion of an evaluation, KEGE Center for ADHD outlines individualized recommendations based on clinical findings. Medication management is provided when indicated, with follow-up visits used to monitor response and adjust plans as needed. When additional counseling support is recommended, providers refer patients to trusted outside therapists and continue to coordinate ADHD care over time.

For children ages six to twelve, KEGE Center for ADHD may use KEGE Bridge as part of the evaluation process when appropriate. KEGE Bridge is a secure system for gathering teacher or caregiver feedback to strengthen diagnostic accuracy. The practice noted that information from school and home environments can support more informed planning for pediatric patients.

The organization also continues to use KEGE Connect, a patient portal that supports appointment scheduling, secure communication, and medication refill coordination. According to the practice, consistent communication tools help patients stay informed about follow-up care while reducing administrative challenges during ongoing management.

KEGE Center for ADHD reported that providers place particular emphasis on reviewing evaluation results in practical terms during follow-up discussions. Time is dedicated to explaining diagnostic conclusions, addressing patient questions, and clarifying expectations related to medication monitoring and care coordination. The practice stated that this approach supports informed decision-making and realistic planning.

The organization also noted that coordinated care planning helps patients understand which aspects of ADHD management are handled directly by the practice and which may involve outside providers. By clearly defining roles early in the process, providers aim to reduce confusion and support continuity throughout treatment.

KEGE Center for ADHD added that follow-up planning is adjusted over time based on patient response and evolving needs. Providers continue to review progress during scheduled visits and make changes when clinically appropriate, reinforcing that care planning is an ongoing process rather than a single decision point.

The practice stated that structured documentation plays an important role in care coordination, allowing providers to track evaluation findings, treatment responses, and referral recommendations consistently. This

documentation supports continuity across visits and helps ensure that care decisions remain aligned with clinical findings.

KEGE Center for ADHD also shared that internal review processes are used to maintain consistency across providers. Regular review of evaluation and follow-up protocols helps support alignment with current clinical standards while preserving a predictable experience for patients and families.

Patient feedback is reviewed regularly as part of internal quality monitoring. Verified public data reflects over 250 reviews with a 98 percent five-star rating. While individual experiences vary, the organization noted that clear communication and structured follow-up processes are commonly referenced themes.

The organization further noted that providers encourage patients to ask questions during follow-up visits and to raise concerns as care progresses. Open communication is viewed as an important component of effective care coordination and ongoing management.

KEGE Center for ADHD stated that care planning discussions are documented in a way that supports continuity across appointments, particularly for patients receiving both in-office and online services. This approach helps maintain consistency regardless of how patients access care.

KEGE Center for ADHD emphasized that its services remain focused exclusively on ADHD evaluation and management. The practice does not provide therapy directly and continues to coordinate care through referrals when additional counseling is recommended. All services are available only to Arizona residents, either through the Gilbert office or online throughout the state.

The organization stated that care coordination processes are reviewed periodically to maintain consistency and clarity as patient needs evolve. No changes were announced regarding service scope, provider structure, or geographic availability.
